Buyer is responsible for all additional costs associated with air shipping the puppy.

Selecting Your Pup:

With prior arrangements, puppies will be available for viewing on-site starting June 1, 2007. Picks of the litter will be guaranteed in the order the deposits are received and payments clear. Picks must be made on or before 49 days of age, either by the buyer, or the seller at the buyer's request and in the order guaranteed in the completed purchase agreement. In the event that the buyer is unable to make the pick on or before 49 days of age, the seller will make the pick for the buyer.

Picking Up Your Pup:

Pups shall be picked up on June 22, 2007 (49 days of age). Air shipped pups will be delivered at 56 days of age.
